IS THE DOCUMENT THAT IS PRESENTED ON YOUR BEHALF TO HM CUSTOMS & EXCISE AT PORT/AIRPORT OF ARRIVAL FOR YOUR IMPORTED HOUSEHOLD & PERSONAL EFFECTS TO THE UK

> IMPORTANT NOTES

PLEASE DO NOT RUSH THROUGH THE FORM. INCORRECTLY COMPLETED C'3S CAN DELAY CLEARANCE & DELIVERY AND RESULT IN ADDITIONAL PORT CHARGES AS A RESULT.

CUSTOMS WILL ONLY ACCEPT AN ORIGINAL C3, FAXED/PHOTOCOPIES OF THE C3 WILL NOT DE ACCEPTED.

SHOULD YOU HAVE MORE THAN ONE SHIPMENT (IE SEA & AIR) A C3 MUST BE COMPLETED FOR EACH SHIPMENT.

- PLEASE ANSWER EACH QUESTION CAREFULLY. IF ASKED TO GO DIRECTLY FROM ONE RESPONSE TO ANOTHER, THEREBY PASSING OVER CERTAIN INTERVENING QUESTIONS PLEASE DO SO.

- > PLEASE ANSWER EACH QUESTION. IF YOU HAVE NO GOODS TO DECLARE YOU MUST WRITE "NONE" IN EACH OF THE BOXES.
- ALL ALCOHOL & TOBACCO, IS SUBJECT TO DUTY, EXCISE & VAT. THESE MUST BE DECLARED ON THE C3 AND THE QUESTIONS ANSWERED. IT IS IMPORTANT THAT YOU ARE AWARE FROM THE INVENTORY WHAT CARTON(S) SUCH GOODS ARE PACKED IN AS THIS ALSO NEEDS TO BE STATED ON THE C3

- > PLEASE SIGN, DATE AND SHOW YOUR FULL HOME ADDRESS & TELEPHONE #. IF YOU DO NOT HAVE A PERMANENT RESIDENCE PLEASE DETAIL YOUR TEMPORARY ADDRESS AND TELEPHONE NUMBER.
